Unweighted, Un-Collapsed and Un-adjusted Data

The data presented below are the unweighted, un-collapsed and unadjusted averages for outcomes from the 2020-21 National Core Indicators—Intellectual and Developmental Disabilities In-Person Survey Report. Outcomes are group by domain (that align with Chapters in this report). To read more about collapsing data and risk adjustment see the Methodology section in the NCI-IDD Overview and Methodology chapter of this report.

The “Average” row is the *average of state averages*.

To protect people’s privacy, **we denote data with “n/a” when fewer than 20 people from a state or residence type responded to a question (though their responses are included in the Average).**

Some of the items are from the direct survey and may be answered only by the person receiving services. Others may have been answered by a proxy respondent (during the survey) and some items are drawn from administrative sources. Instances where information may have been collected from a proxy or administrative records are noted in the table titles.

Note

All Californians with an intellectual or developmental disability as defined by California law have both a civil right and an individual entitlement to receive services from the California Department of Developmental Services. These statutory requirements make California’s service system unique and could impact comparisons between its survey results and the results of other states.
