ABOUT NATIONAL CORE INDICATORS

Since 1997, state developmental disability service systems have used the National Core Indicators[®] (NCI[®]) surveys to gather information about the satisfaction, quality of life, and critical life outcomes of those they support. States use this information to track their own performance over time and to compare results across states. NCI's outcome data contributes key information to states seeking to improve services that support people with IDD to live and contribute as valued members of their communities.

THE DATA

This report includes selected findings from the National Core Indicators 2019-2020 Surveys. The surveys are described on the next page.

The data shown in this report are weighted NCI averages. This means the calculations reflect the relative population sizes of participating states and their survey sample sizes. This way, a state that provides services to a larger number of people but uses a sample size similar to other states has a greater influence on the overall NCI average. OBJECTIVES & PLANS

States use the NCI reports to inform their efforts to strengthen LTSS policy, inform quality improvement activities, evaluate programs and policies, and compare state system performance with national norms.

THE SURVEYS

FAMILY SURVEYS

These surveys are mailed out to families (or where applicable, to guardians) of people who receive at least one paid service from the state DD agency in addition to case management.

ADULT FAMILY SURVEY Families of adults (age 18+) with IDD living in the family home

Families or guardians of adults (age 18+) with IDD living outside the family home

FAMILY GUARDIAN SURVEY

THE IN-PERSON SURVEY

Direct surveys of people with IDD (age 18+) who receive at least one paid service (in addition to case management) from the state DD agency.

THE STAFF STABILITY SURVEY

An online survey of provider agencies supporting adults with IDD in residential, employment, day services, and other in-home or community inclusion programs. The survey captures information about wages, benefits, and turnover of the direct care professional workforce hired by these agencies. Agencies are emailed a link to the survey. (State staff provide the email addresses of the agencies.) And agencies respond directly into ODESA.

COVID-19 AND IN-PERSON SURVEYING

The 2019-2020 in-person surveys ended early due to COVID-19; all data collection was halted on April 15, 2020. Very few states had completed data collection by that date. For this reason, NCI decided not to publicly report these data.




